## Community Agreements

1. **We ground ourselves in the fact that anti-capitalism demands anti-racism.** We seek to eliminate and remedy racist oppression created and maintained by white settlers that undermines working class and community solidarity. In this space, we prioritize and believe the voices of people of color and indigenous people, while also acknowledging our own complicities in white supremacy and U.S. imperialism.
2. **We keep progressive stack.** An assigned individual will keep list of names from people who wish to speak, and prioritize folks who are people of color, women, or who have not spoken at the meeting.
3. **(WAIT) Why am I talking?** When in discussion, consider what you want to say, and if it has already been said. Is there a better time or place to speak? Are there other methods
4. for you to show how you feel about the conversation, such as nodding your head?
5. **Make space, Take Space.** When finished making your point, let others speak. Respect others by recognizing how much, often, and loud you're speaking and if you might be dominating conversation. We also encourage quieter individuals to contribute to the conversation.
6. **Speak from personal experience.** Use "I statement." Speak from your perspective and experience, rather than assuming those of other peoples.
7. **One diva, one mic.** One person should be speaking at any given time. Please refrain from commenting until after they have finished.
8. **Listen (don't wait to talk).** Genuinely pay attention to what others say. Active listening is important in any discussion.
9. **Assume full humanity.** Recognize we were all raised in the same society with the same biases and prejudices, and approach each other with this in mind.
10. **Oops, ouch.** Acknowledge when you've made a mistake. Nobody is perfect and mistakes will be made.
11. **Jargon Giraffe.** Raise your hand (press your thumb against your middle & ring fingers for the shape of a giraffe head!) if you do not understand a term or phrase, and someone will explain the definition to you.

**-Josh moves the Grievance Process: advocates a committee based model; emulates the world we want to live in; a world where people who experience harm are listened to and believed; rejects carceral state;**

**-Speaker against: Andrea speaks against process; asking for membership not to approve it at this time; believes areas in the policy need to be revised; believe revoking**

membership should be kept with the SC; asks that you don't vote for it until you've read it

-Amy speaks for the policy: concerns come from a good place; imagine a world that is welcoming, more responsive; SC members not properly trained in handling grievances and shouldn't be in charge of all the power to revoke membership

-Steve speaks against policy: believes you need to read the whole policy before voting on it; taking away power from members by giving it to Grievance Advocate

**Motion to approve the Grievance Process. Seconded. Requires 2/3 majority. The chair sees a 2/3rds majority and the Grievance Process is adopted.**

10. Voting: Resolution on Reproductive Justice

**-Will be read out loud**

**-Mandy presents the Resolution on Reproductive Rights**

**-Reproductive justice goes beyond abortion access, but we need to defend these basic human rights**

**-Mandy reads the resolution as our projector screen is not working**

**-The speaker asks if there is any debate. There is no debate.**

**-Vote is in order. All in favor, none opposed. Motion passes unanimously. The Resolution on Reproductive Justice is adopted.**

## **Steering Committee Meetings Recaps**

### **June 6, 2019 Steering Committee Meeting**

- The SC talked about some successes and struggles each member has had lately in TCDSA in an effort to connect with each other and the rest of the chapter better.
- The SC discussed the vacancy of the Co-Chair position and Rita was nominated to be interim co-chair until the July General meeting. The motion was seconded and voted upon. The motion passes with 1 abstention and all remaining in favor.
- The SC discussed the next General Meeting business items and threw some ideas out there about different education options.
- Discussion of the timeline for Delegates and fundraising
- Tabled the discussion of the Ops vacancy until Ops was ready to discuss it more
- Scheduled a supplementary meeting for June 20, 2019 on Zoom.

### **June 20, 2019 Supplementary Steering Committee Meeting**

- Discussed a chapter-wide facilitation training
- Talked more about the Ops Coordinator vacancy; Ops is discussing the possibility of changing the position to more of a committee instead; Conversation tabled until Ops could talk more in-depth about their needs.
- General meeting planning discussion
- Request for endorsement from Teamsters for a Democratic Union for a fundraiser in late July; discussed and motion to table the vote until a later time when we can figure out the complex nature of the request
- Request for endorsement from member Elizabeth for the MIRAC & allies action to keep families together; Discussion; Motion to endorse, second, all in favor, none opposed. Motion passed.
- Fundraising check-in and help with organizing the fundraiser party

### **July 18, 2019 Steering Committee Meeting**

- Ops has requested that any available SC members attend a meeting on July 29th to discuss the Ops Coordinator vacancy
- Recap of visit from Regional Coordinator Amy
- Finalized agenda and Pol Ed for General Meeting
- Discussed tentative plans for the September Convention
- Checked in with the Political Platform Committee; they requested the SC appoint a point person for the political platform Committee to have someone held accountable for the work on it
- Motion to appoint Deb as coordinator for the Political Platform; seconded; no debate; all in favor, none opposed; motion passed.
- Fundraising report: fundraising has been going incredibly well!
- Will be checking in with the Grievance WG to talk about assigning Grievance Officers

## **Basics Behind Robert's Rules of Order**

### **MAIN MOTION**

You want to propose a new idea or action for the group.

- After recognition, make a main motion.
- Member: "I move that\_\_\_\_\_."
- All motions must be seconded or they expire.
- Unless not debatable, motions are debated until ready for a vote (see below)
- A new motion is *not in order* when another motion is "on the floor" ie being considered, *except* a motion to amend the motion *or* moving the previous question.

### **PREVIOUS QUESTION**

You think discussion has gone on for too long and you want to stop discussion and vote.

- After recognition, "I move the previous question."
- Must be seconded.
- Not debatable. Immediate vote on call of previous question, and if successful, immediate vote on the present motion.

### **EXTEND DEBATE**

Rules say the debate is over, but you need more time.

- After recognition, "I move to suspend the rules to extend debate by \_\_\_\_\_."
- Must be seconded.
- Not debatable. Immediate vote, and if successful, debate continues on the present motion.
- Not in order if the previous question has been called (above.)

### **ADJOURNMENT**

You want the meeting to end.

- After recognition, "I move to adjourn."
- Always in order.
- Must be seconded.
- Not debatable. Immediate vote and if successful, the meeting is over.

***The following are Points of Order rather than Motions and are always in order.***

### **POINT OF PERSONAL PRIVILEGE**

The noise outside the meeting has become so great that you are having trouble hearing.

- Without recognition, "Point of personal privilege."
- Chair: "State your point."
- Members: "There is too much noise, I can't hear." (Example)

### **POINT OF ORDER**

It is obvious that the meeting is not following proper rules.

- Without recognition, "Point of order."

### **POINT OF INFORMATION**

You are wondering about some of the facts under discussion, such as the balance in the treasury when expenditures are being discussed.

- Without recognition, "Point of information."
