## **Community Agreements**

- 1. We ground ourselves in the fact that anti-capitalism demands anti-racism. We seek to eliminate and remedy racist oppression created and maintained by white settlers that undermines working class and community solidarity. In this space, we prioritize and believe the voices of people of color and indigenous people, while also acknowledging our own complicities in white supremacy and U.S. imperialism.
- 2. We keep progressive stack. An assigned individual will keep list of names from people who wish to speak, and prioritize folks who are people of color, women, or who have not spoken at the meeting.
- 3. **(WAIT) Why am I talking?** When in discussion, consider what you want to say, and if it has already been said. Is there a better time or place to speak? Are there other methods
- 4. for you to show how you feel about the conversation, such as nodding your head?
- 5. **Make space, Take Space.** When finished making your point, let others speak. Respect others by recognizing how much, often, and loud you're speaking and if you might be dominating conversation. We also encourage quieter individuals to contribute to the conversation.
- 6. **Speak from personal experience.** Use "I statement." Speak from your perspective and experience, rather than assuming those of other peoples.
- 7. **One diva, one mic.** One person should be speaking at any given time. Please refrain from commenting until after they have finished.
- 8. Listen (don't wait to talk). Genuinely pay attention to what others say. Active listening is important in any discussion.
- 9. **Assume full humanity.** Recognize we were all raised in the same society with the same biases and prejudices, and approach each other with this in mind.
- 10. **Oops, ouch**. Acknowledge when you've made a mistake. Nobody is perfect and mistakes will be made.
- 11. **Jargon Giraffe**. Raise your hand (press your thumb against your middle & ring fingers for the shape of a giraffe head!) if you do not understand a term or phrase, and someone will explain the definition to you.

### **Steering Committee Meeting Recaps**

The Steering Committee met on August 26, 2019. Here are the decisions and discussions that were had during that meeting:

- SC discusses the Grievance Process. Nic moved that we appoint MacKenzie as the Interim Grievance Process Advocate until the September Convention where will we elect full term Grievance Process Advocates. Seconded, All in favor, none opposed. Motion passed.
- Electoral Branch requested a \$100 reimbursement for tabling at Open Streets for Bernie 2020 as a joint event with UMN YDSA. So moved. Seconded. All in favor, none opposed. Motion passed.
- Racial Justice Branch had a party. Amy motioned to reimburse funds up to \$250. Seconded. 7 in favor, 2 abstentions. Motion passed.
- SC discussed Operations Committee's expectations for the SC, especially in regards to general meeting planning.
- SC discussed the planning of the September Chapter Convention.
- Motion that the SC not accept nominations for the position of Operations Coordinator for the September Convention, per Ops' request. Seconded. All in favor, none opposed. Motion passed.
- Rita requested SC members continue to think about Political Expectations of the SC and Cultural Development Expectations of the SC.
- SC discussed up/down voting online when business can't wait until the next meeting. Often unanimous support in these votes as of late. Nic proposed creating a private Slack channel for all time-sensitive votes online so that we will be able to have better debate online; then having the Recording Secretary keep record of votes and posting a summary and results in our public SC channel; any non-time-sensitive things will be postponed until next SC meeting; all debate will be open for 24hours before a vote is posted; adding some shorter zoom call meetings to our schedules to reduce the time we have to wait to decide on some things and reduce stress in our regular SC meetings. Majority of the SC is in favor of this.

## **Basics Behind Robert's Rules of Order**

#### MAIN MOTION

You want to propose a new idea or action for the group.

- After recognition, make a main motion.
- Member: "I move that\_\_\_\_\_."
- All motions must be seconded or they expire.
- Unless not debatable, motions are debated until ready for a vote (see below)
- A new motion is *not in order* when another motion is "on the floor" ie being considered, *except* a motion to amend the motion *or* moving the previous question.

#### **PREVIOUS QUESTION**

You think discussion has gone on for too long and you want to stop discussion and vote.

- After recognition, "I move the previous question."
- Must be seconded.
- Not debatable. Immediate vote on call of previous question, and if successful, immediate vote on the present motion.

#### EXTEND DEBATE

Rules say the debate is over, but you need more time.

- After recognition, "I move to suspend the rules to extend debate by \_\_\_\_\_."
- Must be seconded.
- Not debatable. Immediate vote, and if successful, debate continues on the present motion.
- Not in order if the previous question has been called (above.)

#### ADJOURNMENT

You want the meeting to end.

- After recognition, "I move to adjourn."
- Always in order.
- Must be seconded.
- Not debatable. Immediate vote and if successful, the meeting is over.

#### The following are Points of Order rather than Motions and are always in order.

#### POINT OF PERSONAL PRIVILEGE

The noise outside the meeting has become so great that you are having trouble hearing.

- Without recognition, "Point of personal privilege."
- Chair: "State your point."
- Members: "There is too much noise, I can't hear." (Example)

#### POINT OF ORDER

It is obvious that the meeting is not following proper rules.

• Without recognition, "Point of order."

#### POINT OF INFORMATION

You are wondering about some of the facts under discussion, such as the balance in the treasury when expenditures are being discussed.

• Without recognition, "Point of information.

<b>Co-Chair 1:</b> The Co-chairs shall be the chief executives of the TCDSA and shall serve as spokespersons when one is required.	
Tim Schaefer:	This chapter and DSA have helped make me into a more skilled organizer and a reluctant leader — after many years of talking about socialism without actually practicing it. Like most of my Twin Cities DSA comrades, I've only been an active member for a few years. We're a quickly growing chapter filled with newly radicalized leftists, many of whom are still finding their footing as socialists. And right now, we have plenty of talented organizers, but we need many more. I believe that DSA has become an essential part of the re-emerging American left and that Twin Cities DSA is becoming a powerful force for good locally, statewide, and regionally: as an electoral power, as an agent of rapid and radical political change, as a means to community and mutual aid in a culture where those phenomena seem to be disappearing. I want to work with our membership, as co-chair, to ensure that there are resources and space to knock on doors for Bernie, unionize every workplace, take over city councils, shut down oil pipelines, democratize our food and energy production, and seize power away from capital for good. What that looks like — and where we apply our strength next — should be decided by our chapter, transparently and democratically. I intend to help that process along, to provide guidance where needed, but have zero interest in being "in charge." As your co-chair, I want to develop a practice of radical empathy, true democracy, and collective strength. We don't need more bosses — we need each other.

**Grievance policy coordinator(s):** The GPA is responsible for supporting the initial needs of the grievance process when voted in by the general membership. The GPA cannot hold any additional elected roles in the chapter. The GPA will advocate for the successful implementation of the grievance process as written and voted on by the chapter; coordinate trainings for grievance committee volunteers and TCDSA officers/leaders; and track training completed and maintain up-to-date lists of volunteers qualified by training requirement completion to participate in the grievance committee. The GPA will provide guidance, support, facilitation, and coordination necessary to initiate the grievance process until/unless the grievance committee finds the GPA's role unnecessary. With the help of experienced practitioners and coalition partners, training is planned and will begin soon! I am excited to continue to work with other folks on this process and continue to learn as we work to build the abolitionist, anti-carceral future we want to live in!
Julia Tindell:	I began working in the anti-violence field in 2014 but it wasn't until I worked with my comrades in TCDSA to draft our grievance process that I really understood what it looks like to build a future free from violence. We have a strong foundation, rooted in Black socialist feminism and steeped in the care of its original stewards. Still, there is much to be done. In the coming months, we will recruit a diverse grievance committee, invest in knowledge-building and skill-sharing, and begin the messy process of pulling together our communal response to harm. This work is political, technical, emotional, exhausting, energizing, defeating, and empowering all at once. It will draw out our own personal experiences of trauma, and it will shine a light on the ways ALL of us are capable of causing harm. As a grievance process advocate, I would be committed to sharing all of the knowledge, skills, and resources I have collected in the last 5 years of my work; investing in new relationships and opportunities to grow our community; and encouraging all members of DSA to invest in their own journeys of healing (myself included). It was an honor to shepherd the process along before it was passed, and it would be an honor to advocate for it to come alive in the capable hands of my comrades. Thank you for your consideration. Solidarity!

**Political education coordinator**: The role of Political Education Coordinator requires that a person help generate and organize regular events that help further the analysis and skills of members of the Twin Cities DSA chapter and anyone of the local community also interested in socialism and socialist organizing. Additionally, as a listed member of the Steering Committee the PolEd coordinator must be available to engage with the Steering Committee on a regular basis including SC meetings, online discussions and online votes.

Debra Keefer Ramage:	I want to facilitate answering the pressing and expressed needs of members, both highly involved and those who are not but would like to be, for two things - knowledge, and social space-time. The latter is actually spelled out in the bylaws as a responsibility of the PEC, and
	almost everyone agrees we could use more purely social, chapter-wide events. I want to make that happen. Knowledge, on the other hand, is power. We have knowledgeable and powerful members and we can teach each other. Although I want to do a few teach-ins myself, I mainly

	see me in this role as coordinating, seeking out, and activating the amazing teachers we already have.
Kevin McClean:	I am interested in the political education coordinator position because while talking with several other members of the chapter we have come to realize that for the TCDSA to succeed we need to create self-sustaining spaces where people can join together to discuss socialist politics. The immediate goal would be to establish monthly Socialism 101s and Organizing 101s that have a minimal barrier to entry. Once those are established, we would work on creating spaces for more advanced discussion (socialist night school, socialist imagination series, book and film clubs, etc.) that would allow us to further refine and discuss our politics. All of this would be done with an eye on creating solidarity among members of the chapter and with working people within the Twin Cities community.

**Recording secretary**: Duties of the RecSec include: attending Steering Committee and General Meetings on a regular basis, being able to listen and take notes on a computer, clean up documents and keep files organized in Google Drive, work with the Ops Committee and SC to provide meeting minutes or answer questions about meetings that may arise, be available for members who have questions about the meetings, and contribute thoughtful responses in SC meetings.

Tracy Waterman:	Hello! You might know me from the socialist feminist branch, the ops committee, the check-in table, convention delegate elections, or the many announcements I've made at chapter meetings in the past couple of years. In that case, you'll have gathered that I believe in getting shit done. I also believe (firmly! I'll fight about it!) in information as a powerful organizing tool. When we make information accessible, we democratize access to power, too. That's why I think the office of recording secretary is political, and that's also why it's a job I'm interested in doing. I'm looking forward to working with our brand new communications committee to help make information flow smoothly throughout the
	chapter.

**Technology coordinator:** The TCDSA Technology Coordinator is responsible for maintaining the chapter's website, databases, email addresses, and other infrastructure. They are also responsible for implementing chapter social media and member data policies. The tech coordinator typically works closely with the operations committee. Some of the day to day tasks include making updates to the website as requested and sending email password resets. Longer term tasks include researching new software and tools that the chapter could adopt.

Hi there! I'm Eugene. I have been active in TCDSA since late 2017, and I've spent much of my time in the operations committee, where I help plan chapter meetings, among other tasks. As the TCDSA technology coordinator for the past year, I have dealt with the nitty-gritty of our chapter's recent expansions. I upgraded our email system, improved access to chapter resources, and generally made sure everything ran smoothly. If re-elected tech coordinator, I would look forward to maintaining and expanding our tech infrastructure as we continue to grow. I would also like to continue pursuing our tech-related chapter goals, including making our website more accessible to new users, improving chapter opsec, and deploying new tools that we can use to make the work that TCDSA members do more effective.

**Treasurer**: The Treasurer is responsible for tying out chapter finances and providing a report on them at least quarterly, with additional reports for specific fundraising or general meetings as necessary. They will chair a budget/fundraising meeting quarterly after each of those reports to discuss and direct the future of the chapter's finances. The treasurer is also responsible for filing federal taxes and for ensuring reporting compliance on the federal, state and municipal level for any political campaigns the chapter is involved in.

Ezra Ishman:	Socialism is ultimately about the democratic control of the economy. As Treasurer, my goal will me to maximize member engagement through
	participatory budgeting and fundraising. It is our dues money and labor which keeps our chapter vibrant and growing. I also aim to reinvigorate the Solidarity Fund through various means so we can more effectively embody our shared values of community and mutual aid.

## **Proposed Resolutions**

### **Resolution: Resolution to Defer Operations Coordinator Election**

#### WHEREAS,

- 1. The work of the Operations Committee is a vital part of successful organizing in TCDSA;
- 2. More than one Operations Coordinator has left TCDSA without completing a term, citing burnout and an unreasonable workload;
- 3. Due to these unexpected departures, the chapter has operated without an Operations Coordinator since April 2019;
- The division of the Operations Coordinator role into Operations and Technology Coordinator in 2018 was necessary but not sufficient to make the role sustainable for one person;
- The planned redistribution of chapter meeting planning responsibilities among Operations Committee and Steering Committee members will help mitigate, but not solve, the workload problem;
- 6. A Communications Committee has recently formed and plans to work with the Operations Committee and assume some of its current responsibilities;
- The Steering and Operations Committees agreed at a joint meeting on August 15 that our best course of action is to defer the scheduled election of an Operations Coordinator;

BE IT RESOLVED,

- 1. There will be no election for Operations Coordinator at the 2019 TCDSA Convention;
- 2. The Operations and Steering Committees will reconvene before the end of the 2019 calendar year;
- 3. At that time, the two committees will decide whether or not it is feasible to elect a new Operations Coordinator, and will plan to either hold the election at the next general meeting or draft any necessary bylaw amendments, whichever is appropriate.
